- Novel coronavirus: Until 5 days have passed since the onset of symptoms and 1 day has passed after symptoms have subsided
- \* "Symptoms are relieved" means that the fever is relieved without the use of antipyretics, and the respiratory symptoms are improving.
- \*1The pathogen is a coronavirus of the genus Betacoronavirus (limited to those newly reported from the People's Republic of China to the World Health Organization in January 2020 as having the ability to infect humans). Limited to things.
  - Influenza: Until 5 days have passed since the onset of symptoms and 2 days have passed since the fever subsided
    - \* If the school doctor or other doctors confirm that there is no risk of infection, you can come to school.
    - \* Fever is the state in which the body temperature is less than 37.4 degrees both in the morning and in the evening. \*2 Excluding pandemic influenza, avian influenza, etc.

- \* "Mild symptoms" means that the fever is relieved without the use of antipyretic drugs and the respiratory symptoms are improving.
- \*1 The pathogen is limited to coronaviruses of the genus Betacoronavirus (limited to those newly reported to have the ability to transmit to humans from the People's Republic of China to the World Health Organization in January Reiwa 2).
- Influenza: Until 5 days have passed since the onset of the disease and 2 days have passed since the fever has been eliminated
- \* If the school doctor or other doctor recognizes that there is no risk of infection, you can come to school.
- \*Antipyretic is a condition in which the body temperature is below 37.5 degrees Celsius in both morning and evening.
